# Annual Performance Report for Marion Preparatory Academy

# SY 2022-2023 DATA

The North Central Ohio Educational Service Center (NCOESC) community school sponsorship seeks to develop positive relationships and support school leaders/developers who provide high-quality educational experiences for students throughout the state of Ohio. Every year, the NCOESC provides an Annual Performance Report for each of its sponsored community schools. The following report provides an overview of the school and a summary of its performance in academics, fiscal, organizational/operational, and adherence to legal compliance over the most recent school year and the term of the sponsorship contract.

NCOESC provides rigorous oversight, monitoring, and technical assistance to our sponsored schools with processes and protocols that align with standards developed by the National Association of Charter School Authorizers and the state of Ohio's Sponsor Performance Review. NCOESC collects data from its sponsored schools throughout the year to determine specifically the extent to which each school is performing in the following four areas: academic, fiscal, operational/organizational and legal compliance. Data gathered through a variety of means reviewed and analyzed to determine school's performance includes the following:

- Site visits to schools, including walkthroughs while school is in session with findings reported to the governing authority at meetings;
- Monthly financial reviews;
- Attendance at community school governing authority board meetings;
- Ongoing reviews of assessment data highlighting student achievement and growth;
- Ongoing reviews in the areas of state and federal compliance, academics, special education, operations, and finance;
- Ongoing technical assistance delivered by trained and experienced staff; and,
- Reviews of reports electronically submitted to the NCOESC compliance-tracking database.

## ACADEMIC SUMMARY

#### (Did not meet Expectations)

Marion Preparatory Academy (MPA) state testing results in 2022-2023 show significant drops in three of the four components on the local report card from 2021-2022. The table below compares scores from 2021-2022 to 2022-2023 state report cards.

The Achievement Component measures students' academic achievement using each level of performance on Ohio's State Tests. The achievement component grade on the Ohio Report card represents whether student performance on state tests met established thresholds and how well students performed on state tests overall. Marion Preparatory Academy's data results from the 2022-2023 school year show downward trends in performance indicators and performance index in all grade levels (with the exception of 3<sup>rd</sup> grade ELA). Performance Indicators had a significant drop of 19.2 points from the 2021-2022 school year. These two components determine the achievement outcome on the local report card which was 1 star.

The Progress Component measures the academic performance of students compared to expected growth on Ohio's State Tests. MPA's results show that there is significant evidence that the school fell short of

student growth expectations by a larger magnitude. This is surprising since the results the year before showed just the opposite.

The Gap Closing component shows how well schools are meeting the performance expectations for our students in English language arts, math, and graduation. It also measures how schools are doing in supporting English learners to increase language proficiency, reducing chronic absenteeism for all students, and identifying gifted students and providing gifted services. MPA does not identify gifted students, but they do have the following sub group categories; economically disadvantaged, students with disabilities, Black/non-Hispanic, Hispanic, & Multi-racial. Each of these groups are looked at specifically to determine how well these marginalized groups of students are performing. MPA does not have a graduation measure or an English-learner group. Chronic absenteeism is looked at for all groups mentioned above as well as boys & girls.

The Early Literacy Component examines the effectiveness of the reading and literacy supports provided to children in kindergarten through third grade. It is composed of three unrated measures that contribute to the overall rating. These measures are proficiency in third grade, promotion to fourth grade and improving K - 3 literacy (reading improvements from grades K - 3).

A deep dive into the Academy's data to determine the root causes of the significant changes in these outcomes is recommended. MPA has a new school leader in place for the 2023-2024 school year and a school-wide improvement plan has been developed and implemented. As the sponsor of Marion Preparatory Academy, we are confident that academic improvements for all students will be made this school year.

Areas of focus for school improvement are listed above. Along with all components of the local report card, an additional area for improvement is chronic absenteeism. However, the Academy did lower this measure from 56.9% (2021-2022) to 44.6% (2022-2023) these are still much higher than the state goal of 20.2%.

Regarding non-academic performance there are no concerns at this time. Thank you to school leadership and to MPA's Governing Board for your commitment and dedication to providing great oversight and leaning opportunities for the students in the Marion area.

## FISCAL SUMMARY

#### (Met Expectations)

As your sponsor, we appreciate the diligence of the board and school leaders in making sure the school is fiscally sound to operate and to maintain a balance of per-pupil spending while providing students with a good educational experience. #### **LEGAL COMPLIANCE**

#### (Met Expectations)

NCOESC rated the school's Legal Compliance based on a combination of its adherence to state and federal statute, the community school contract, and compliance items from the sponsor evaluation. A school will have met expectations if it has a 100% compliance rate with health and safety requirements (identified on the sponsor evaluation school compliance doc) and at least 95% for all requirements.

During the 2022-23 school year, Marion Preparatory Academy (MPA) worked diligently to adhere to all compliance expectations set forth in their sponsorship contract with North Central Ohio Educational Service Center and with all rules and law for community school operations. MPA submitted documentation for evidence of adherence to all rules and laws to the sponsor through Epicenter, which in turn, the sponsor submits to the Ohio Department of Education Department of School Choice.

We thank MPA for your continued efforts towards compliance with all rules & laws and for getting all documentation uploaded in a timely manner. As the sponsor of MPA, we will continue to work collaboratively and strive to meet a goal of zero non-compliant items for the 2023-24 school year. In addition, as more requirements are identified and required by The Ohio Department of Education, we will continue to work collaboratively with MPA to ensure compliance with all rules and laws related to school operation in accordance with the Ohio Department of Education.

#### **CORRECTIVE ACTION PLAN (CAP)**

Corrective Action is not necessary for Marion Preparatory Academy at this time. However, a school-wide improvement plan is in place and supported by the sponsor. We thank you for your efforts in maintaining operations in serving students in the Marion area. We are proud to sponsor MPA and we value our partnership. We look forward to continuing to support you in your endeavors and wish you continued success!
